WHAT IS THE APPLICATION FOR?

Validation Application on Payment Guarantee/Invitation is to be applied for using a special lane at airports when entering Cambodia. There are two types of applications:



Sponsorship (Sponsored by Company)

Travelers are financially covered in entirety by the inviting company in case the travelers are tested positive for Covid-19 and/or required to quarantine by the Cambodian government. Once the application is approved, the travelers will be issued a Validation Certificate on Payment Guarantee.



Invitation Only (Self-Sponsored)

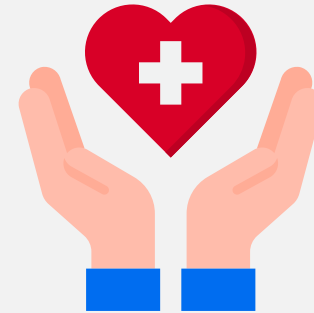
Travelers are invited by the inviting company, but they bear the entire costs should they be tested positive for Covid-19 and/or required to quarantine by the Cambodian government. Once the application is approved, the travelers will be issued a Validation Certificate on Invitation.

WHAT IS THE APPLICATION FOR?

Should the application be the **sponsorship** type, the travelers will be exempt from two Covid-related requirements when travel to Cambodia:



A deposit of USD2,000 upon arrival to Cambodia

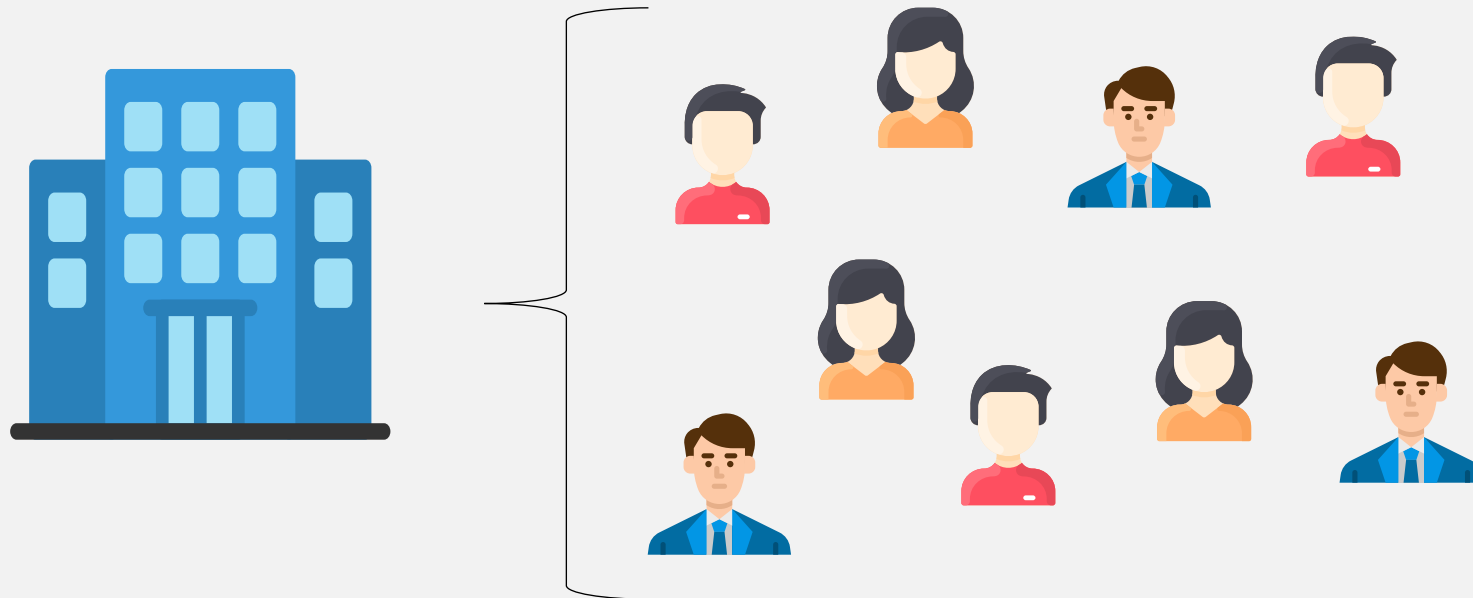


An insurance policy

IMPORTANT: These exemptions will not apply to the invitation-only applications.

WHO CAN APPLY?

A company registered and based in Cambodia can apply for **its business-linked travelers** including investors, business people, experts, technical workers, professional staff and their family members. The guarantor must be a director or a shareholder of that company.



WHEN TO APPLY?

At least **72 hours** prior to the departure to Cambodia

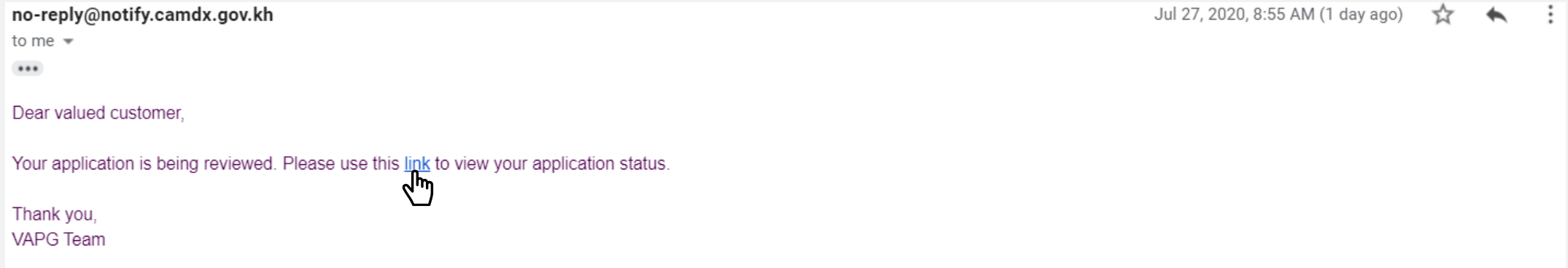


